

## Meeting Minutes – September 14, 2021 – Zoom Meeting

- 1. **Call to order**: Bryan called the meeting to order at 5:04 pm.

- 4. Reports/Discussion

Planning and Design: Matt Steele discussed the need and options to get signs developed and installed for "The Gap" on both the east and west side of Co. Rd. 31 in Crosby. Also discussed the ownership of the property on the north side of Deer Trail where the eastern portion of "The Gap" exists. The church does not own the property as presumed in earlier discussions. More to follow. Brainerd Landowners: Bryan sent a letter to Anderson Brothers and spoke to Jim Anderson who is the person managing the vacant property between Pine Shores Rd and Jordan Rd in east Brainerd. Mr. Anderson is an active bicyclist and is excited to work with the association to make something work. He is out of state until spring and will contact us when he returns. Riverton Landowners: Surveys of the two Riverton parcels are complete. Communication between the landowners and MN Parks and Trails Council will be next. Drainage Field Discussion: SEH engineer reviewed our trail development plans and communicated options to the Mayor of Riverton. A curvature to the trail to the west was suggested by the engineer to provide a larger area east of the trail for drain field development. Wade M. mentioned future trail development can place whatever is needed beneath the trail to accommodate future drain field planning options.
